PRE-QUALIFYING CONDITIONS OF THE TENDERERS:

The bidder have to fulfill following minimum conditions of experience and financial competence in order to qualify for consideration this tender.

11.(A) EXPERIENCE :-

- The bidders should have successfully executed on turnkey basis at least one (1) substation or switch yard of 33 KV or above voltage class during last Seven(7) years ending last day of the month previous to the one of opening of bid and which would have run satisfactorily for at least two (2) years
- II. The bidders should, have constructed and commissioned transmission lines/laying of underground cables at least of aggregate route of 10 kms or more of 11 KV or above voltage class which must be successfully completed and handed over to the utility.

 The cost of the works mentioned above should not be less than 5 Crores.

11.(B) FINANCIAL CAPABILITY:-

I. Minimum Annual Average Turnover (MAAT)

MAAT of the bidders should be at least 20% of the estimated package cost during the last three years ending 31st March of the previous financial year.

IL Liquid Assets (LA)

LA of a bidder should not be less than the 20% of the package cost for which the offer is submitted or Rs. 10.00 crores whichever is more.

III. Net worth

The bidders should not have incurred any loss in more than two years during the last 7 years. The firm should have a positive net worth.

IV. In case bidder is a holding company. MAAT, LA and Net worth referred to in clause 11(B) I, ii & iii above, shall be of that holding company only (i.e. excluding its subsidiary, group companies). -

V. In case bidder is a subsidiary of a holding company, MAAT, LA and Net worth referred to in clause 11(B) I, ii & iii above, shall be of that subsidiary company only (i.e. excluding its holding companies).

12. JOENT VENTURE/CONSORTIUM

12.1 In order to fulfill the above qualifying conditions the bidder can form a consortium/joint venture of maximum two companies. In such cases the figures of each of the consortium/joint

venture partner shall be added as detailed below to determine the bidder's compliance of the above minimum qualifying criteria.

12.2 In case of consortium/joint venture at least one partner should fulfill the technical

experience requirements.

12.3 One of the two partners of consortium/joint venture should be registered in C.&D.S., U.P. Jal Nigam. The partner registered in C.&D.S., U.P. Jal Nigam can only be nominated as the lead partner.

12.4 The partner of consortium/joint venture shall meet financial qualifying criteria as mentioned

at clause II(B) I, ii & iii jointly.
