- 2- Bids must be accompanied by Earnest Money Deposit (EMD) in shape of unconditional and irrevocable Bank Guarantee issued by any Nationalized Bank in the standard format as shown in the Tender Bid document or crossed Demand Draft of **Rs. 490.00 lakhs** (i.e. 0.5% of ECV) drawn in favour of Director, C&DS, U.P.Jal Nigam along with bids. Successful bidder shall have to submit Security Deposit @ 1.5% of contract value in addition of EMI at the time of agreement.
- 3- Downloaded E.M.D. and processing fee forms are to be attached with the bids in hard copy alongwith a soft copy and be submitted to the **General Manager (N-12), C&DS, U.P.Jal Nigam Lucknow** so as to reach on or before 3.00 P.M. on Date 14.05.2010, either personally or through courier or by Post and the receipt of the same within the stipulated time shall be the responsibility of the bidder. Failure to furnish the original DD/BG towards EMD and DD for processing fee will render the Bid invalid.
