Terms & Conditions:

- 1. The Bid document may be downloaded from "https://etender.up.nic.in" w.e.f. 22.06.2020.
- 2. The Bid should be valid for 180 days from the last date of submission of bids. Bids submitted, cannot be withdrawn after last date & time of submission.
- 3. If the date of opening of technical bid happens to be a holiday, the bid shall be opened on the next working day at the same time for which no separate communication shall be sent.
- 4. Bidders having criminal record will not be allowed to participate in Bid process.
- 5. A person registered with any State Bar Council will not be eligible to participate in the Bid.
- 6. Joint Ventures is allowed.
- 7. Bidders who inter alia fulfil the following requirements shall be eligible to apply.
 - i) Any legal entity with having 10 years of consultancy experience, an office in India, registration under Indian companies Act. 1956, valid PAN, GST registration. Firms of foreign origin, if registered in India under Indian Companies Act and having its business establishment in India will be also eligible for participation provided firm's total consultancy experience in India and abroad is equal to or greater than 10 years.

- ii) Applicant Firm must possess ISO:9001 certification for last 5 years as on last date of bid submission.
- iii) Any Firm blacklisted or debarred by any State/Central Government / Semi Government Organization / Funding Agency (e.g. World Bank, ADB, NABARD etc.) during last 3 years from the last date of bid submission shall not be eligible.
- 8. **Financial Capacity**: The Firm shall have a minimum Annual Turnover of Rs. 20.0 (Rupees Twenty) crore per annum from professional fees in any 3 (three) financial years during last seven years from Indian Operations only.

AND

The Firm should have experience in Project Management Services of at least one single project of the value of not less than Rs. 100 Crores in last five years.

Financial capability of parent company shall not be considered in case of any Indian Subsidiary.

- 9. The department reserves the right to reject any prospective application or to cancel entire bid process without assigning any reason whatsoever.
- 10. Tender Fee / Bid Document Fee (non refundable) and Bid Security / EMD:
 - a. Proposals shall need to be accompanied by Tender Fee / Bid Document Fee and Bid Security / EMD as cited above, which is required to be deposited strictly in the manner and mode described in relevant section of RFP Document.
 - b. Tender Fee / Bid Document Fee and Bid Security / EMD are not exempted in any case and Proposals/Bids without Tender Fee / Bid Document Fee and Bid Security / EMD shall be summarily rejected.
- 11. The bid submission shall become invalid if:
 - (i) The bidder is found ineligible.
 - (ii) The bidder does not upload all the documents as stipulated in the bid document.
 - (iii) If any discrepancy is noticed between uploaded documents and originals/hard copies submitted later on demand.
 - (iv) If subsequent to due date of submission of bid and/or after its submission bidder makes any further communication/ representation with the department with regard to the bid (whether technical or financial) than otherwise called for by the undersigned as a clarification.
- 12. Canvassing whether directly or indirectly, in connection with bids is strictly prohibited and the bids submitted by the bidders who resort to canvassing will be liable for rejection & will be debarred from future tender in C&DS, U P Jal Nigam.
- 13. The bidder shall not be permitted to bid for works under supervisory control of General Manager concerned who is responsible for RFP processing, in which his near relative is posted. He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any officer in the C&DS.
- 14. No Engineer or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the STATE GOVERNMENT/State Department Undertaking is allowed to work as a contractor for a period of two years after his retirement from Government service, without the prior permission of the Government of U.P. in writing. This contract is liable to be cancelled if either the contractor or any of his employees is

found any time to be such a person who had not obtained the permission of the Government of U.P. as aforesaid before submission of the bid or engagement in the contractor's service.
