3. Bidders having criminal record will not allowed to participate in Bid process.

4. A person registered with any State Bar Council will not be eligible to participate in Bid.
5. Travel Agency/firms should be registered in GST. **Joint ventures are not allowed.**
6. Information and instruction for bidders posted on website shall form part of bid document.
7. The bid document consisting of Technical and financial bid and other necessary document are available on "<http://e-tender.up.nic.in>".
8. The bid will be opened on due date and time as mentioned above in the presence of bidders present. Technical Bids will be evaluated for their responsiveness and technical requirements. Financial offers of bidders found to be responsive and technically qualified will be opened in II stage for which information will be given through the e-tendering portal mentioned as above.
9. The department reserves the right to reject any or all prospective application without assigning any reason.
10. 

13. The bidder will in addition to other document, upload scanned and digitally signed copies of proof of cost of bid document, earnest money as described above and standard affidavit in prescribed form '**I-B**' at the time of opening of the bid.
14. The above originals may be submitted either by person or through speed post.
15. All the document as specified in the Technical bid/eligibility bid document should be uploaded within the period of bid submission.
16. The bid submission shall become invalid if:
  - (i) The bidder is found ineligible.
  - (ii) The bidder does not submit/upload all the documents as stipulated in the bid document.
  - (iii) If any discrepancy is noticed in hard copies as submitted **physically by the bidder** in the office of bid opening authority.
  - (iv) The bidder does not Deposit valid original EMD, tender fee and affidavit in the office of "**Director, C&DS, U.P. Jal Nigam(Urban), Lucknow**" before stipulated date and time.
